NOTIFICATION

No.SOT(M&M)3-1/2015(Vol-II).- In exercise of the powers conferred under section 2 of the Regulation of Mines and Oil-fields and Mineral Development (Government Control) Act, 1948 (XXIV of 1948), Governor of the Punjab is pleased to make the following amendments in the Punjab Mining Concession Rules, 2002 with immediate effect:

AMENDMENTS

In the Punjab Mining Concession Rules, 2002:

- (1) In rule 2:
 - (a) for clause (v), the following shall be substituted:

“(v) Department” means the Mines and Minerals Department, Government of the Punjab;” and
 - (b) after clause (xxxv), the following new clause shall be inserted:

“(xxxv-a) “Secretary” means the Secretary to Government, Mines and Minerals Department”.
- (2) In rule 4:
 - (a) in sub-rule (1), in clause (g), for the word “Government”, occurring for the second time, the word “Secretary” shall be substituted; and
 - (b) in sub-rule (4), for the word “Government”, the words “Licensing Authority” shall be substituted.
- (3) In rule 72, for the word “Government”, the words “Licensing Authority” shall be substituted.
- (4) In rule 76, for the word “Government”, the word “Secretary” shall be substituted.
- (5) In rule 78, for the word “Government”, the word “Secretary” shall be substituted.
- (6) In rule 79, in sub-rule (1), for the word “Government”, the words “Licensing Authority” shall be substituted.
- (7) In rule 84, in sub-rule (3), for the word “Government”, the words “Licensing Authority” shall be substituted.

- (8) In rule 89, for the word "Government", wherever occurs, the word "Secretary" shall be substituted.
- (9) In rule 94:
- (a) in sub-rule (1), for the words "Government in the Department", the word "Secretary" shall be substituted;
 - (b) in sub-rule (2), for the word "Government", the word "Secretary" shall be substituted; and
 - (c) in sub-rule (3), for the word "Government", occurring for the first time, the word "Secretary" shall be substituted.
- (10) In rule 185-A:
- (a) in sub-rule (1), for the word "Government", occurring for the second time, the word "Secretary" shall be substituted;
 - (b) in sub-rule (1), in the proviso, for the word "Government", the word "Secretary" shall be substituted;
 - (c) in sub-rule (2), for the word "Government", the word "Secretary" shall be substituted; and
 - (d) in sub-rule (3), for the word "Government", occurring for the first time, the word "Secretary" shall be substituted.
- (11) In rule 187, in sub-rule (1), for the word "Government", wherever occurs, the word "Secretary" shall be substituted.
- (12) In rule 197, for the word "Government", the word "Secretary" shall be substituted.
- (13) In rule 203, for the word "Government", the words "Licensing Authority" shall be substituted.
- (14) In rule 207-A, for the word "Government", the word "Secretary" shall be substituted.
- (15) In rule 228, in the second proviso, for the word "Government", the word "Secretary" shall be substituted.
- (16) In rule 235:
- (a) in sub-rule (1), for the word "Government", occurring for the second time, the word "Secretary" shall be substituted;

- (b) in sub-rule (1), in the proviso, for the word "Government", the word "Secretary" shall be substituted;
- (c) in sub-rule (2), for the word "Government", the word "Secretary" shall be substituted; and
- (d) in sub-rule (3), for the word "Government", the word "Secretary" shall be substituted.

(17) In rule 236:

- (a) in sub-rule (1), for the word "Government", the word "Secretary" shall be substituted; and
- (b) in sub-rule (2), for the word "Government", the word "Secretary" shall be substituted.
