

**ORDINARY SAND ZONE ML-BKH-ORD SAND-BHAKKAR NOTAK BEHAL ZONE (2)**

**DISTRICT BHAKKAR**

a) **Geological Survey, Location of the Zone and assessment of Mineral in The Zone:**

The zone falls on Topo Sheet No.39/M-2 & M-3 of Survey of Pakistan comprising over an area of 48553.71 acres. Geologically the zone consists of alluvial sand deposits of Thal Desert outside the Bhakar city, Notak & Behal Town which are abundantly available in the area in Tehsil & District Bhakkar. The sand can easily be excavated after removal of soil up to 05-07 feet. The thickness of sand deposits varies from place to place and ranges between 08-10 ft (approx.). It is not possible to estimate underground sand deposits by ordinary means about 70% area of zone comprises upon sand bearing deposits.

b) **Quality of the Mineral in the Zone.**

An average to good quality of sand is available in the area. The ord sand having bed of approximately 08-10 ft is available under silt bed.

c) **Availability of access Roads to the Zone:**

The zone is easily accessible through Bhakkar-Notak Behal Road. The said roads are passing within the zone area.

d) **Accessibility to the Market and Consumption of the Mineral in the Zone:**

The main consumption market of this zone is in Bhakkar city, Notak, Behal and surrounding areas.

**ORDINARY SAND ZONE ML-BKH-ORD SAND-BHAKKAR ZONE (1) (REVISED)**

**DISTRICT BHAKKAR**

a) **Geological Survey, Location of the Zone and assessment of Mineral in The Zone:**

This zone is located in Thal desert near Bhakkar City and town Chak No.49, District Bhakkar. The said zone falls on Topo Sheet No 39 M/2 of Survey of Pakistan over an area of 22727.27 acres on Bhakkar-Khansar Road adjacent to Bhakkar City. Geologically, fluvial sand deposits are abundantly available in the zone. The sand can easily be excavated after removal of soil up to 05-07 feet. The thickness of sand deposits varies from place to place and ranges between 08-10 ft (approx.). It is not possible to estimate underground sand deposits by ordinary means however 40-50% area of zone comprises upon sand bearing deposits.

b) **Quality of the Mineral in the Zone.**

An average to good quality of sand is available in the area. The ord sand having bed of approximately 08-10 ft is available under silt bed.

c) **Availability of access Roads to the Zone:**

The zone is easily accessible through Bhakkar-Khansar and Bhakkar-Jhang Road. The said roads are passing within the zone area.

d) **Accessibility to the Market and Consumption of the Mineral in the Zone:**

The main consumption market of this zone is in Bhakkar city, Chak No.49 and surrounding areas.

e) **Average Excavated quantity of the Mineral from the Zone during Last Five Years**

**ORDINARY SAND BLOCK ML-BKH-ORD SAND- MANKAIRA (1) (Revised)**  
**DISTRICT BHAKKAR**

**a) Geological Survey, Location of The Zone and assessment of Mineral in The Block:**

This block is located in Thal desert near Mankaira City District Bhakar. The said block falls on Topo Sheet No 39 M/7 of Survey of Pakistan over an area of 496.07 acres on Bhakkar-Jhang Road at a distance of about 65 kms from Bhakkar City. This block comprises over sand dunes and some un-level cultivated land wherein alluvial ghassar/bhassar deposits are abundantly available which can easily be excavated after removal of soil up to 02-03 feet. The thickness of sand deposits varies from place to place and ranges between 04-06 ft (approx.). It is not possible to estimate underground sand deposits by ordinary means however 30-40% area of block comprises upon sand bearing deposits.

**b) Quality of the Mineral in the Block-**

Most of the area comprised over ghassar deposits, however low quality Sand having bed of about 04-06 feet is available under soil bed.

**c) Availability of access Roads to the Block:**

The said block is easily accessible through Mankera-Nawan Kot Road at a distance of about 03 Kms from Mankera City.

**d) Accessibility to the Market and Consumption of the Mineral in the Block:**

The main consumption market of this block is in Mankaira city.

**e) Average Excavated quantity of the Mineral from the Block during Last Five Years**

An average excavation during past 5 years cannot be assessed as no record in this regard is maintained in this office, however, reportedly, an average excavation of sand ranges from 5 to 10 trollies per day are being excavated depending upon demand.
